

#### **Use Case: Al Tools**

That means sensitive data is flying through prompts, chats, and responses. But employees don't always think before they share. That means that customer records, financial data, or internal intel can end up in a prompt or be pulled into a generative reply. Once data is pulled into an AI tool, it's out of your hands.

## **Use Case: Data Privacy**

A single slip, like credit card numbers ending up in a downloaded report or patient records being found in chats, can result in major violations, fines, and brand damage.


